PRELIMINARY INJUNCTION

Defendants, and all individuals who serve as Defendants' officers, agents,
servants, employees and attorneys, and other persons who are acting in active
concert or participation with Defendants, their officers, agents, servants employees
or attorneys, ARE HEREBY PRELIMINARILY RESTRAINED AND ENJOINED
as follows:

7 Defendants will not, directly or secondarily, publicly perform, 1. 8 reproduce, distribute, or otherwise infringe in any manner (including without limitation by materially contributing to or intentionally inducing the infringement 9 10 of) any of Plaintiffs' rights under 17 U.S.C. § 106 of the Copyright Act in any motion picture, the rights to which Plaintiffs own or control ("Copyrighted Works"); 11 Except to as requested by Plaintiffs, Defendants shall not transfer or 12 2. 13 otherwise relinquish control to the domains: mediahosting.one, crystalcleariptv.com, ccmedia.one, ccbilling.org, cciptv.us, ccreborn.one, 14 15 ccultimate.one, superstreamz.com and webplayer.us; and Defendants will not knowingly take any action for the purpose or that 16 3. 17 has the effect of circumventing the requirements of this Preliminary Injunction. 18 IT IS FURTHER ORDERED that, except as requested by Plaintiffs, GoDaddy Inc. and One.com, the respective domain name registrars for the 19 20mediahosting.one, crystalcleariptv.com, ccmedia.one, ccbilling.org, cciptv.us, 21 ccreborn.one, ccultimate.one, superstreamz.com and webplayer.us domain names ("Infringing Domain Names"), as well as all others who receive notice of the 22 23 Court's order, are enjoined from allowing the Infringing Domain Names to be 24 modified, sold, transferred to another owner, or deleted. Such entities are further ordered to disable access to the Infringing Domain Names. As part of 25 accomplishing this, these entities shall take the following steps: 26 27

A. Maintain unchanged the WHOIS or similar contact and identifying
 information as of the time of receipt of this Order and maintain the Infringing
 Domain Names with the current registrar;

- B. Prevent transfer of the Infringing Domain Names and any further
 modification of any aspect of the domain registration records of the Infringing
 Domain Names by Defendants or third parties at the registrar or by other means; and
- 7 C. Preserve all evidence that may be used to identify the persons using the
 8 Infringing Domain Names.

IT IS FURTHER ORDERED, that Plaintiffs may complete service of process on 9 10 Defendants and any persons who are acting in active concert or participation, including resellers of Defendants' service known to be acting in concert of this 11 Order by Overnight Mail. Upon receipt of a copy of this Order, these individuals 12 13 and entities shall cease directly or secondarily infringing any of Plaintiffs' Copyrighted Works through any means including publicly performing, reproducing, 14 or otherwise infringing in any manner (including without limitation by materially 15 contributing to or intentionally inducing the infringement of) any right under 17 16 U.S.C § 106 in any of Plaintiffs' Copyrighted Works by continuing to provide 17 access to Defendants' service or by any other means. 18

19 IT IS FURTHER ORDERED, that Plaintiffs are not required to post a bond.
20 Plaintiffs' Motion for Preliminary Injunction [12], is vacated and taken off-calendar.
