Hello,

We would like to clarify our recent actions, and explain the motivation behind them and their intended effect.

We have moved PrimeWire to the new domain, PrimeWire.tf, and we are taking action to comply with the temporary injunction. We have remove all links to external video hosting services, excluding the following:

youtube.com  
archive.org  
vimeo.com  
dailymotion.com

We are only accepting new link submissions from these four services. The rationale for doing this is that these four services have strong proactive copyright protection policies, so the likelihood of unauthorized content being served by them is low. However, we recognize that this is not enough. If the Plaintiff, or any other copyright holder finds links on PrimeWire to unauthorized streams of their works, we invite them to send us a notice of the relevant works, and we will remove the links and disable the submission of any further links. As of March 13th, we have already disabled the submission of new links for all 138 works identified by the Plaintiff.

We support points 2 and 4 of the proposed permanent injunction. However, we would like point 3 to be amended to exclude PrimeWire.tf, as there is no evidence to suggest that any links to unauthorized streams of the Plaintiffs works is being or has ever been distributed over this domain. We would like to note that under point 4, if it ever becomes apparent that links to unauthorized streams of the Plaintiffs works were being distributed on PrimeWire.tf, then it could at that point be added in the injunction to be frozen or seized.
