**ORDER ISSUING PRELIMINARY
INJUNCTION, PURSUANT TO
PARTIES' STIPULATION**

1 The Court has received the Parties' Joint Stipulation Regarding Entry of
2 Preliminary Injunction ("Stipulation"), (Dkt. No. 44), and therein has found good
3 cause to approve the Stipulation. Therefore, Defendant Dwayne Anthony Johnson
4 d/b/a AllAccessTV and Quality Restreams ("Defendant"), and all persons who are
5 allegedly acting in active concert or participation with Defendant (collectively, the
6 "Enjoined Parties"), **ARE HEREBY PRELIMINARILY RESTRAINED AND**
7 **ENJOINED**, as follows:

8 1. The Enjoined Parties shall not directly or secondarily, publicly perform,
9 copy, reproduce, distribute, stream, transmit, or otherwise infringe in any manner any
10 of Plaintiffs' copyrighted works, or any other works whose copyrights are owned or
11 exclusively controlled by Plaintiffs and/or their affiliates (the "Copyrighted Works"),
12 nor facilitate, induce, or contribute to the unauthorized reproduction and/or public
13 performance of the Copyrighted Works by others.

14 2. The Enjoined Parties shall not operate, or in any way do business as,
15 AllAccessTV and Quality Restreams, and shall not operate any website, application,
16 system, software, or service for purposes of providing unauthorized access Internet
17 Protocol television or video-on-demand to any person or entity.

18 3. To the extent the Enjoined Parties have control over a domain listed below
19 as of the date of this Order, the Enjoined Parties shall not modify, sell, transfer to
20 another owner, or delete any of the following domain names: aatvdigitalmedia.com,
21 aatvpanel.com, aatvapp.live, myaatv.com, aatvdigital.com, aatvwebplayer.com,
22 allaccessiptv.com, allaccessstv.live, tv.allaccessstv.live, vod.allaccessstv.live,
23 kids.allaccessstv.live, aatv.media, qualityrestreams.com, qsplaylist.com,
24 qualitystreamz.guru, qsprovider.com, mediaflo.net, and v2.dmdapi.com (collectively
25 "Domain Names").

26 4. Within five (5) business days of the issuance of this Order, the Enjoined
27 Parties shall park the Domain Names.

28 5. As of the date of this Order's issuance and throughout the pendency of this

1 case, the Enjoined Parties shall not make or cause any changes to be made to the WHOIS
2 or similar contact/identifying information that exists for each Domain Name and shall
3 maintain the Domain Names with the current registrar.

4 6. As of the date this Order's issuance and throughout the pendency of this
5 case, and except as otherwise required to park such Domain Names, the Enjoined
6 Parties shall not further modify any aspect of the domain registration records of the
7 Domain Names.

8 7. The Enjoined Parties shall not knowingly take any action for the purpose,
9 or that has the effect, of circumventing the requirements of the Preliminary Injunction.

10 IT IS FURTHER **ORDERED** that the activities in Paragraphs 3–6 above
11 relating to restrictions on transfers and changes by Defendant as to the Domain Names
12 will *also* apply to NameCheap, Inc. and GoDaddy.com, LLC, the respective domain
13 registrars for the Domain Names, as well as all others who receive notice of this Order,
14 who will be likewise restricted.

15 IT IS FURTHER **ORDERED** that Plaintiffs may complete service of process
16 of this Order on NameCheap, Inc. and GoDaddy.com, LLC and any persons who are
17 allegedly acting in active concert or participation, including resellers, by Overnight
18 Mail.

19 IT IS FURTHER **ORDERED** that Plaintiffs are not required to post a bond
20 relating to the preliminary injunction. Moreover, this Order **MOOTS** Plaintiffs'
21 Motion for Preliminary Injunction. (Dkt. No. 14). The associated hearing, set for
22 February 18, 2022, is therefore **vacated**.


