20 I, Jan van Voorn, the undersigned, declare that:

22 1. I am Executive Vice President and Chief of Global Content Protection
23 for the Motion Picture Association, Inc. (“MPA”). I submit this declaration on
24 behalf of Disney Enterprises, Inc., and Warner Bros. Entertainment, Inc. (“ACE
25 Members”), each of which is a member of the Alliance for Creativity and
26 Entertainment (“ACE”). ACE is a global coalition of leading content creators and
27 on-demand entertainment services committed to supporting the legal marketplace
28 for video content and addressing the challenge of online piracy. The ACE

1 Members, whether themselves or through subsidiaries and affiliates, own the
2 copyrights for *Frozen II* and *Godzilla vs. Kong* which are infringed as follows:

17 Inc. to disclose the identities, including names, physical addresses, IP addresses,
18 telephone numbers, e-mail addresses, payment information, account updates and
19 account histories of the users operating the websites strims.tv,
20 tvlinkcanada.cc/tvlink-v3.apk and tvlink.one.

21 3. The purpose for which this subpoena is sought is to obtain the identities
22 of the individuals assigned to these websites who have exploited ACE Members'
23 exclusive rights in their copyrighted motion pictures without their authorization.
24 This information will only be used for the purposes of protecting the rights granted
25 to ACE Members, the motion picture copyright owners, under Title II of the Digital
26 Millennium Copyright Act.
