 10 Inc. to disclose the identities, including names, physical addresses, IP addresses,
 11 telephone numbers, e-mail addresses, payment information, account updates and
 12 account histories of the users operating joymovies.123streamcms.bid.

13 3. The purpose for which this subpoena is sought is to obtain the identities
 14 of the individuals assigned to these websites who have exploited ACE Members’
 15 exclusive rights in their copyrighted motion pictures without their authorization.
 16 This information will only be used for the purposes of protecting the rights granted
 17 to ACE Members, the motion picture copyright owners, under Title II of the Digital
 18 Millennium Copyright Act.
