1 The Court having considered the Complaint, Entry of Default and Motion  
2 for Default Judgment as to Defendant Nguyen Hoi (“Motion”), and the pleadings  
3 and papers presented in connection with Motion, finds as follows:

4 Plaintiff’s Motion for Default Judgment is **GRANTED**. Accordingly:

- 5 1. It is hereby **ORDERED, ADJUDGED and DECREED** that Defendant  
6 Nguyen Hoi pay to Plaintiff MG Premium Ltd. the sum of \$117,270,000 in  
7 statutory damages on the cause of action for Copyright Infringement;
- 8 2. It is hereby **ORDERED, ADJUDGED and DECREED** that Defendant  
9 Nguyen Hoi pay to Plaintiff MG Premium Ltd. its attorney’s fees of  
10 \$4,002.67 and costs of suit of \$667.87 for a total of \$4,670.47;
- 11 3. It is hereby **ORDERED, ADJUDGED and DECREED** that Defendant  
12 and their respective agents, servants, and employees, and any other persons  
13 or entities acting on their behalf shall be permanently enjoined from  
14 infringing upon any of Plaintiff’s copyrighted works.
- 15 4. It is hereby **ORDERED, ADJUDGED and DECREED** that Cloudflare,  
16 Inc. and Namecheap.com be permanently enjoined from continuing any  
17 service contracts or services to Defendant operating PornEZ.net.
- 18 5. It is hereby **ORDERED, ADJUDGED and DECREED** that Verisign, Inc.  
19 and any other registries and registrars of the domain name PornEZ.net, shall  
20 (i) make the web site and any other content located that the domain name  
21 inaccessible to the public; (ii) transfer the domain PornEZ.net to MG  
22 Premium Ltd., including changing the registrar of record to the registrar  
23 selected by MG Premium at MG Premium’s reasonable expense; and (iii)  
24 after the transfer, reenable the domain name so that MG Premium may fully  
25 control and use the domain name.
