22 6. These videos are not intended for viewing for free or by persons that are
23 not paid members of MG Premium Ltd.'s web sites.

7. MG Premium Ltd.'s paid membership web sites include brazzers.com,
realitykings.com, men.com, seancody.com, mofos.com, digitalplayground.com,
babes.com, twistys.com, lilhumpers.com, bromo.com, realitydudes.com, and
trueamateurs.com.

8. Membership to MG Premium Ltd.'s web sites range in cost from \$9.99
 per month to \$39.99 per month.

9. Potential MG Premium Ltd users will, in all likelihood, not pay monthly
rates for the right to access and view content that is available for free.

5 10. MG Premium Ltd goes to great lengths to obtain high quality movies,
6 which are in turn desired by MG Premium Ltd.'s customers. It therefore additionally
7 hurts MG Premium Ltd.'s brand if MG Premium Ltd.'s videos are associated with
8 low quality movies.

9 11. MG Premium Ltd. invests human and technological resources and incurs
10 considerable expenses to commission and broadcast high quality movies. It hurts MG
11 Premium Ltd.'s ability to continue broadcasting new high-quality movies if MG
12 Premium Ltd.'s videos are accessible for free because it hinders its ability to earn
13 income.
