23 for the Motion Picture Association, Inc. (“MPA”). I submit this declaration on

25 Paramount Pictures Corp., and Warner Bros. Entertainment, Inc. (“ACE Members”),
26 each of which is a member of the Alliance for Creativity and Entertainment
27 (“ACE”). ACE is a global coalition of leading content creators and on-demand
