Dear Sir or Madam,

Our law firm has filed a Federal copyright infringement lawsuit in the U.S. District Court for the District of Hawaii on behalf of our client, **HB Productions, Inc.** regarding the websites ibit.uno and mkvcage.com. Our investigation has confirmed that these websites are responsible for a significant number of copyright infringements of our client's motion picture *Hellboy* in the United States and in Hawaii in particular.

In response to a subpoena per 17 USC 512, Tucows stated that you (1337 Services LLC) are the registrant for the website ibit.uno. We subsequently determined that you are also the registrant for mkvcage.nl – the successor website to mkvcage.com. We previously reached out to you via email to attempt to discuss this issue but received no response. It is our understanding that Tucows forwarded to you a copy of the DMCA notice we sent to them regarding ibit.uno. The point is you have received multiple notifications that make you aware of the infringing nature of these websites, yet you continue to allow these websites to operate.

We would like to discuss the possibility of resolving this issue with you and possibly come to an amicable resolution. We will require that you remove all torrent files associated with our clients' motion pictures and adopt filtering mechanisms to prevent any further unauthorized distribution from these websites.

Do I need my own attorney?
