20 I, Jan van Voorn, the undersigned, declare that:

22 1. I am Executive Vice President and Chief of Global Content Protection  
23 for the Motion Picture Association, Inc. (“MPA”). I submit this declaration on  
24 behalf of Disney Enterprises, Inc., Netflix Worldwide Entertainment, LLC,  
25 Paramount Pictures Corp., and Warner Bros. Entertainment, Inc. (“ACE Members”),  
26 each of which is a member of the Alliance for Creativity and Entertainment  
27 (“ACE”). ACE is a global coalition of leading content creators and on-demand  
28 entertainment services committed to supporting the legal marketplace for video

1 content and addressing the challenge of online piracy. The ACE Members, whether  
2 themselves or through subsidiaries and affiliates, own the copyrights in the below  
3 referenced copyrighted works.

4 2. The ACE Members (via the Motion Picture Association, Inc.) are  
5 requesting issuance of the attached proposed subpoena that would order Tonic  
6 Domains Corporation to disclose the identities, including names, physical addresses,  
7 IP addresses, telephone numbers, e-mail addresses, payment information, account  
8 updates and account histories of the users operating the following websites:


