

platforms (all together referred to in this letter as “**Sky Channels**”). Sky invests substantial sums in producing and acquiring content for broadcast on the Sky Channels, including a wide range of live media rights across major sports events, movies, entertainment and documentaries.

Sky is the owner of the broadcast copyright in all Sky Channels in accordance with sections 6, 21 and 23 of the Copyright and Related Rights Acts 2000, as amended (the “**2000 Act**”).

Your Infringing Activities

It is clear from Sky’s investigations that you were a subscriber to the IPTV Is Easy subscription service (the “**Infringing Activities**”). Such activity involves substantial acts of copyright infringement.

The Infringing Activities involve acts of copyright infringement including, without limitation:

1. without the licence of Sky as copyright owner, undertaking an act restricted by copyright (s.37(2) of the 2000 Act); and
2. having in your possession, custody or control an article designed or adapted for making copies of copyrighted work knowing or believing it has been or is to be used to make infringing copies of copyrighted work (s.46 of the 2000 Act).

Your Infringing Activities may also involve criminal offences by:

1. having received a broadcast to which rights protection measures have been applied, knowing or having reason to believe that it is being received unlawfully with the intent to avoid payment (s.371 of the 2000 Act). Or
2. having in your possession, custody or control a protection defeating device, knowing or having reason to believe it has been used or is to be used to circumvent rights protection measures (s.140(4) of the 2000 Act).

You are clearly aware that Sky has not consented to the copying and making available of the content accessible via the Infringing Activities.

Action you should take

This letter **requires** you to take the following steps, but before doing so, you should read the whole of this letter and the attached FAQs carefully:

1. Stop The Infringement Immediately

You must immediately and permanently disable all subscriptions to IPTV services you have access to.

2. Respond to this Letter and Provide Undertakings

Sky requires you to immediately acknowledge receipt of this letter, provide signed undertakings and contact us to discuss the contents if anything is unclear.

Sky is fully prepared to take further legal action, including issuing court proceedings, against you to protect its copyright works but preferably Sky is willing to resolve the matter quickly with your co-operation and compliance.

In the circumstances, Sky requires you to sign and return the settlement agreement and undertakings (a legally binding promise) in the form attached to this letter at Annex 1 (“**Undertakings**”).



The required actions are set out in further detail in the Undertakings. As you will see, the Undertakings set out Sky's requirements that you refrain from all future and current association with illegal IPTV services.

Compliance with Undertakings

Sky will keep a record of your name, address, this letter, and (if provided) your undertakings. This record will be retained for as long as is necessary for Sky to enforce its intellectual property rights, including for the duration of any applicable limitation period under Irish law. If Sky becomes aware in future that you have been involved with illegal IPTV services again, Sky shall consider the undertakings to have been breached and may bring legal proceedings against you.

The following Irish copyright owners – Clubber TV, LOITV, GAA+, and Premier Sports – are all wholly aware that the illegal IPTV service you purchased is infringing their copyrighted content too. They are fully supportive of the action being taken against you by Sky and suggest in the strongest terms possible that you comply. Your failure to do so may leave them with no other option but to take firm action against you themselves.

SETTLEMENT AGREEMENT & UNDERTAKINGS

Dear Sky UK Limited

I acknowledge receipt of the letter sent to me by Sky and dated DATE 2026 (the “**Letter**”). Defined terms below have the definitions as set out in the Letter.

In consideration of Sky not bringing legal proceedings against me in respect of my acts of copyright infringement as set out in the Letter, but without prejudice to Sky’s rights in relation to any other or subsequent infringement by me of Sky’s copyright, **I hereby undertake** (whether acting by myself, directly or indirectly or by any company, its directors, officers, employees, agents or otherwise) as follows:

Cease and Desist

1. To immediately and permanently disable all means provided through or by the Infringing Activities to stream copyright content owned or controlled by Sky, including (without limitation) the Sky Channels (i.e. to expire immediately my IPTV subscription(s)).
2. To never again infringe Sky’s copyright in any way including by watching any of its content or channels without paying the correct subscription fee to Sky.
3. To never again subscribe to an illegal IPTV service.
4. Not to take any steps to transfer control or information relating to the Infringing Activities to any other person(s) now or in the future.

Breach of Undertakings

5. I understand that if I breach these Undertakings, Sky shall be entitled to seek damages from me in respect of the full amount of my infringement.



Confidentiality

I acknowledge that Sky may, as it wishes, issue media and other public statements about this matter and/or related initiatives, which will record, amongst other things, that they have taken successful action against the Infringing Activities. However, I also acknowledge that these public statements will not name me personally if I am compliant with the terms of these Undertakings.

I confirm that I have read and understood the Undertakings I have given above. I understand that an undertaking is a contractually binding promise and I have [taken independent legal advice in connection with the giving of such an undertaking] * OR [chosen not to obtain independent legal advice.] *
