23 for the Motion Picture Association, Inc. (“MPA”). I submit this declaration on
24 behalf of Disney Enterprises, Inc. and Warner Bros. Entertainment, Inc. (“ACE
25 Members”), each of which is a member of the Alliance for Creativity and
26 Entertainment (“ACE”). ACE is a global coalition of leading content creators and
27 on-demand entertainment services committed to supporting the legal marketplace
28 for video content and addressing the challenge of online piracy. The ACE

16 to ACE Members, the motion picture copyright owners, under Title II of the Digital
17 Millennium Copyright Act.
