THE COURT HAS ORDERED THAT

Plaintiff's motion for default judgment (Dkt. No. 24) is GRANTED.

It is hereby ORDERED, ADJUDGED and DECREED that Defendant Popravkin Anton, together with all of his officers, directors, agents, servants, employees, representatives, affiliates, successors, and assigns, and all other persons, firms, or companies in active concert or participation with him, are permanently enjoined and restrained from directly or indirectly: a. manufacturing, distributing, marketing, advertising, promoting, or selling or authorizing any third party to manufacture, distribute, market, advertise, promote, or sell any products, works, or other materials that include, copy, are derived from, or otherwise embody any copyrighted work of Aylo Premium Ltd; b. reproducing, distributing, performing, or publicly displaying any copyrighted work of Aylo Premium, Ltd., creating any derivative works based on those works, or engaging in any activity

that infringes Plaintiff's rights in those works; and c. aiding, assisting, or abetting any other individual or entity in doing any act prohibited by sub-paragraphs (a) or (b).

It is further ORDERED, ADJUDGED and DECREED that Defendant Popravkin Anton, in accordance with 17 U.S.C. § 504(c)(2), shall pay to Plaintiff statutory damages in the amount of \$90,060,000, with interest on these principal amounts according to the statutory rate pursuant to 18 U.S.C. § 1961(a). This amount consists of \$10,000 for each of the registered copyrighted works that Aylo owns and that Popravkin Anton willfully and maliciously infringed.

It is further ORDERED, ADJUDGED and DECREED that Defendant Popravkin Anton, in accordance with 17 U.S.C. § 502(a), shall pay to Plaintiff its reasonable attorney's fees and costs in the amount of \$20,350.

It is further ORDERED, ADJUDGED and DECREED that Verisign, Inc. shall change the registrar for the domain names 3prn.com, freshporno.net, frprn.com, homexvideo.com, kojka.com, mojva.com, onlineporno.cc, and pornheal.com to EuroDNS, and instruct EuroDNS to change the registrant for those domain names to Aylo Premium Ltd.

Violation of this Order shall subject Popravkin Anton and all other persons bound by the Order to all applicable penalties, including contempt of Court. The Court shall retain jurisdiction over this action for the purpose of enforcing this final judgment and permanent injunction.
