1 Petitioner MVL Film Finance LLC (“MVL”), through undersigned counsel
2 and its authorized representatives, hereby requests that the Clerk of this Court,
3 pursuant to the Digital Millennium Copyright Act (“DMCA”), 17 U.S.C. § 512(h),
4 issue the attached proposed subpoena to Instagram, LLC to identify alleged
5 infringer(s) of MVL’s copyrighted works.

6 MVL has satisfied the requirements for issuance of a subpoena pursuant to
7 17 U.S.C. § 512(h), namely:

- 8 (1) MVL has submitted a copy of the notification required by 17 U.S.C.
9 §512(c)(3)(A) as set forth in the Declaration of Matthew Slatoff, filed
10 concurrently herewith;
- 11 (2) MVL has attached hereto a proposed DMCA subpoena; and
- 12 (3) MVL has submitted a sworn declaration confirming that the purpose
13 for which the proposed subpoena is sought is to obtain the identity of
14 the alleged infringer(s), and that such information will only be used for
15 the purpose of protecting MVL’s rights under U.S. Code Title 17.

16 Having complied with all statutory requirements, MVL respectfully requests
17 that the Clerk expeditiously issue and sign the proposed subpoena pursuant to 17
18 U.S.C. § 512(h)(4) and return it to undersigned counsel for service on the subpoena
19 recipient.
